## **New model for opening for entry from EU and Schengen countries, as well the UK**

---

The current entry restrictions will be replaced by a new model for opening the borders to the EU and Schengen area, as well as the UK, using objective criteria about the respective health situation in each country and guided by a principle of caution.

The new model will take effect on Saturday, 27 June 2020. A list of open and quarantine countries will be released prior to this date. From then on, Statens Serum Institut will prepare a weekly consolidated table of the individual countries' scores on quantitative criteria. On the basis of these weekly scores, the countries will be classified as "open" or "quarantine country", to be used by the Ministry of Foreign Affairs of Denmark and the Danish Police in their work.

A safety valve will be established for extraordinary situations not covered by the model, such as a situation where the spread of infection increases rapidly in a region or a country, or where Statens Serum Institut assesses that information or other data is inaccurate. In these cases, the entry of tourists from the region or country in question may be completely prohibited, the list of worthy purposes may be narrowed, and the travel advice risk level may be revised to "red", i.e. travel of any kind to the region or country is not advised.

Certain worthy purposes will be expanded to apply for countries outside of the EU and Schengen area, as well as the UK. The expansion will include boyfriends/girlfriends, fiancées, grandparents and grandchildren, as well as business travel, job interviews, etc.<sup>1</sup> However, it will be mandatory to present a negative test performed no later than 72 hours before entry into Denmark, except in the case of business travel, which was already considered a worthy purpose prior to the expansion.

A model is also being developed for re-opening the borders for tourists from certain third countries with a sufficiently developed testing regime, reliable reporting, and general handling of the pandemic that is comparable with the efforts of European countries. These countries must also meet the criteria established for opening the borders for tourists from the EU and Schengen countries, as well as the UK.

<sup>1</sup>Although of less relevance for third countries, the expansion also includes persons who own a holiday home in Denmark or who can provide documentation that they are solely passing through Denmark in transit for the purpose of holiday or tourism outside of Denmark. Holiday flats, allotment gardens, and caravan sites at campgrounds in Denmark are treated as holiday homes under these regulations.

Incidence* ( <i>when a country is "open"</i> )	Incidence per 100,000 inhabitants per week is under 20.
Critical level ( <i>when a country goes from open to quarantine</i> )	Incidence per 100,000 inhabitants per week is equal to or more than 30.

<b>Open countries</b>	Effective 27 June 2020, the border will be re-opened for entry by tourists. Entering tourists must be planning to stay in Denmark for at least six nights. Travellers are encouraged to be attentive to their personal safety and keep up to date (yellow). ### Testing regime in borderland and summer holiday tourism areas

<b>Testing at land boundaries</b>	<p>As society re-opens for tourists – and Danes increasingly travel abroad – the authorities’ testing programmes are expanding so that those entering Denmark by car will have the opportunity to take a COVID-19 test at the border crossings. Some border crossings will have testing available at all times, while testing at other locations will be offered periodically.</p> <p>Based on identified entry patterns and demand, the authorities will also assess the need to establish additional permanent testing stations at relevant border crossings.</p>
<b>Testing in summer holiday tourism areas</b>	<p>Mobile solutions will be established throughout Denmark, e.g. in connection with ferry arrivals, making it as easy as possible for people entering Denmark to be tested.</p> <p>The mobile testing stations will also be deployed at hotspots, enabling testing of employees of shops, amusement parks, restaurants, etc.</p>
<b>Testing at Copenhagen Airport</b>	<p>Effective Monday, 15 June 2020, a permanent testing station opened at Copenhagen Airport.</p>
