## UPDATE as of 18.3.2020 Extension of short stay visas and residence permits Coronavirus Disease COVID-19

The Ministry of Foreign Affairs of Denmark, Protocol Department, presents its compliments to all Heads of Diplomatic Missions accredited to Denmark and to International Organisations and Other Missions resident in Copenhagen and has the honour to share the following information:

Please note that, unfortunately, it is currently not possible to apply for an extension of a short stay visa in Denmark. This is due to the fact that the Danish Immigration Service's Citizen Service is closed for visitors. Furthermore, it is not possible to apply for an extension online nor at the Danish Police. However, the Danish Immigration Service has decided to disregard a possible overstay of a short stay visa period if it is caused by applicants being prevented from leaving Denmark, e.g. due to suspension of flights.
