II. Introduction and background

The rationale behind EASO support to the Egyptian authorities in the area of international protection and asylum lies with the first meeting of the Egypt-EU Migration Dialogue, which took place on 17 December 2017 in Cairo. Following the Dialogue, the European Commission, taking stock of the interests expressed by Egyptian authorities, proposed follow-up action points, including potential support by EASO in the areas of international protection and asylum, and prevention of and fight against irregular migration, migrant smuggling and trafficking in human beings¹.

This resulted in the first EASO-Egypt cooperation which was implemented in 2019-2020.

Additionally, the Egyptian authorities requested EASO presence in ongoing regional trainings conducted by the CCCPA (Cairo International Centre for Conflict Resolution Peacekeeping and Peacebuilding) in

2018, 2019 and in 2020. An EASO representative of the Vulnerable Groups team with specific expertise on THB has been regularly delivering presentations on EASO tools and trainings on THB in this context.

Based on several exchanges during the activities implemented in 2019-2020 and in *ad-hoc* consultations with Egyptian authorities, EASO and the Egyptian counterparts (hereinafter Egypt) agree on the present Roadmap document built around main topics of interest/need as outlined in the Summary section below.

III. Methodology

Needs Assessment and Rationale for the intervention

In line with the background explained above, the present document has been developed using a participatory approach where EASO and Egypt have been working together in the drafting and identification of areas of cooperation. It outlines relevant areas for the delivery of targeted capacity-building activities to be implemented using EASO expertise and with the participation of EU MS experts, in partnership with Egypt. It gathers input also from relevant stakeholders in order to achieve a shared and coordinated set up for the implementation of the foreseen actions.

The Roadmap implementation timeframe is agreed to be of 24 months, starting on August 2020 until July 2022.

To allow sufficient **flexibility and adaptability to the needs and resources** of both sides, this document can be revised, if need arises, upon agreement of EASO and Egypt.

Monitoring and Evaluation

To ensure progress is monitored and **support delivered in a sustainable way**, as per EASO methodology (such as the EASO Needs Assessment User Guide), indicators for each activity will be developed. These will also support the continued improvement and adaptation of the document to meet the needs of EASO and EG and to adapt activities to respective available resources.

EASO will request Egypt to fill in activity evaluation reports/forms and a mid-term/final general surveys to be able to monitor and evaluate the implementation of the activities foreseen in the present document. The outcome will be shared with Egypt and the incorporation of any changes based on lessons learnt gathered from this exercise will be subject to mutual agreement between EASO and Egypt.

During the implementation phase, EASO and Egypt agree to an **open two-way communication** to ensure technical level, day-to-day support and/or technical advice will be provided in line with the main areas of cooperation identified in the present document and compatibly with the normal workload of relevant resources.

Mid-term and final evaluations will be performed and a final meeting with Egyptian representatives will be organised by EASO in order to discuss progress as well as the content of any needed adjustment or possible extension of cooperation, based on lessons learnt and best practices.



IV. General Pre-conditions and Assumptions

- The identified resources, on both EASO and Egyptian side, are available for effective and timely implementation;
- The implementation of the activities included in the present document entails no costs for Egyptian authorities;
- All proposed activities are mutually identified and agreed by Egypt and EASO;
- o Relevant national authorities/stakeholders will participate in the proposed activities;
- o Activities may change as new information is gathered during implementation;
- o EASO and Egypt are willing to exchange experiences and take into consideration best practices;
- o EASO and Egypt are willing to maintain an open two-way communication at technical level.

V. Summary

As a result of the participatory approach explained above and of the joint assessment of needs, EASO and Egypt have identified areas pertaining to the asylum field where specific interests and needs can be addressed by an enhanced cooperation through EASO capacity building activities. Here a summary of the areas of priority and the related outcomes and outputs:

I. Supporting the establishment of asylum-related legislation, institutions and systems in Egypt

1. Asylum-related institutional capacity in Egypt is strengthened

During the current law-drafting phase, Egypt would like **to build further expertise on asylum-related matters in order to inform the design of its own national asylum law**, also in view of the technical needs linked to the foreseen establishment of an asylum body/agency dedicated to this field of work. In this context and building on the results achieved with the implementation of the first cooperation activities in 2019-2020, EASO and Egypt have identified the logic of intervention outlined below.

Outputs:


- 1.1 Egypt expertise on asylum-related matters is enhanced in view of informing the design of national asylum law;
- 1.2 Egypt understanding of methodologies on knowledge management in the field of asylum and reception is strengthened (pilot);
- 1.3 Egypt institutional training capacity on international protection/asylum-related topics, including unaccompanied children, is enhanced.
 - II. Supporting effective international protection procedures in Egypt
- 2. Protection-sensitive migration management capacities are enhanced



EASO and Egypt have identified support/cooperation activities adapted to the current international protection framework in the country. These are aimed at supporting Egypt's efforts to establish relevant technical knowledge, in-house asylum-related training expertise and capacity to implement the future asylum law in a timely manner. The logic of intervention outlined below builds on already achieved results as part of the 2019-2020 cooperation framework, particularly in the field of combating trafficking in human beings.

Outputs:

- 2.1 Egypt institutional capacity on access to international protection is enhanced, including the identification, assessment and referral of persons with special needs, in particular unaccompanied children;
- 2.2 Egypt institutions, competencies and knowledge in the identification, assessment and referral of (potential) victims of THB are enhanced.

include a 'legislative framework' area in the Roadmap, in order to provide EASO and EU MS expertise to inform/support Egyptian asylum law drafting efforts.

At the end of February 2020, EASO and Egypt authorities organised a conference on asylum systems in three EU MS (Belgium, Malta and Netherlands) with models of asylum systems of interest to the Egyptian government. Following the request for information, written outputs were prepared and translated into both Arabic and English on the four asylum systems focusing on specific points of interest, as indicated by Egypt.

Output 1.2 is meant to offer an additional opportunity for benefitting from EASO's expertise and thematic networks on asylum and reception for informing the law drafting process, via the use of written answers/analyses produced by EASO with input from EU MS, based on EG written requests.

Pre-conditions / assumption

For qualitative knowledge management / sharing:

- Egypt identifies the specific areas of interest regarding the organisation of asylum procedures and reception;
- Egypt and EU MS consent to share and provide insights on the identified areas.

For Trainings:

- The training plan is built both in view of the current situation in Egypt and taking into consideration needs that might arise in the next, new asylum law-implementation phase;
- EASO will support the adaptation of the training plan in view of the law implementation phase in coordination with Egyptian counterparts. This will be further developed and implemented once the law will be adopted and as part of an updated Roadmap document;
- Egypt and EASO are willing to share and exchange relevant information and knowledge for the achievement of this result;
- Egyptian authorities identify and appoint officials/practitioners for participating in EASO TtT in view of gradually building a sustainable and specialised pool of national trainers;
- Language: EASO TtT modules that will be delivered in English, require very good knowledge of spoken and written English to ensure trainees' full learning experience, as well as their participation and interaction with the trainers and the fellow trainees;
- National roll-outs: Egypt and EASO trainers deliver the sessions jointly with active participation on both sides, both during online and face-to-face sessions;

Target group

Officials, practitioners in the field of migration/asylum, including first contact points, such as at border entry/exit points, national and local government offices (such as, *inter alia*, representatives from MFA, MoJ, NCCPIM-TIP; NCCM; NCHR, NCW; etc.), jointly identified relevant local CSOs, Community Development Associations and the like.

Other national stakeholders with which Egypt and EASO will agree to seek and establish synergies:

CCCPA for their work on THB at regional level and in order to build on the well-established cooperation so far.

Description and assessment of the situation/ EASO added value

Egypt ratified the 1969 OUA Refugee Convention in 1980, and the 1951 Refugee Convention and its 1967 Protocol in 1981. The functional responsibilities related to registration, documentation, and status determination are currently with UNHCR under the framework of a MoU, signed in 1954 with the Government of Egypt (GOE). Egyptian authorities have responsibilities in different aspects of the procedure, including in the identification and documentation aspects.

Additionally, in October 2016, the Egyptian Parliament approved a new antihuman smuggling law which complements the law no. 64 of 2010 concerning combatting human trafficking. The NCCPIM-TIP is the government focal point for coordinating policies in the field of preventing irregular migration and combating smuggling and trafficking of human beings. The NCCPIM-TIP's mandate is to strengthen the cooperation between and among the National parties (governmental and non-governmental) with regional and international parties to achieve a comprehensive developmental approach to curb irregular migration. NCCPIM-TIP is also in charge of providing/organising relevant training sessions (also in cooperation with other stakeholders) to the members of the Committee as well as to the first contact officials.

So far, under the umbrella of the first cooperation agreement between EASO and Egypt (which was launched in August 2019), three Egyptian officials from the MFA, Prosecutor's Office and CCCPA have been trained on EASO THB module and have supported the delivery of the first national training session held in Cairo in November 2019. Currently (May 2020) two other officials from the NCCPIM-TIP and the Public Prosecutor's Office are attending the EASO TtT e-learning training on THB.

In 2019, a dedicated hotline was created as well as a shelter for victims of human trafficking. The latter is under the MoSS. Other hotlines for women and children as well as on human rights issues have been created and respond to also THB reports/questions/issues. The hotlines have been set up by the NCHR and the NCW. In addition, children victims of THB can receive support by contacting the dedicated hotline managed by the NCCM.

Synergies

In cooperation with the **EU Delegation in Cairo**, synergies will be explored with EU MS and with other donors and relevant stakeholders engaged in Egypt.

In particular, on Output 2.1, EASO will seek the following synergies:

Coordination with UNHCR, IOM and UNICEF on relevant, concrete activities will be sought to avoid duplication and foster synergies.

EASO will seek synergies on Output 2.2with the following actors:

Synergies will be sought with **UNODC⁴**, in light of their ongoing support to relevant national stakeholders, including but not limited to police officers, prosecutors and judges in order to strengthen national capacity to identify potential victims of human trafficking as well as investigate, prosecute and adjudicate crimes of human trafficking and migrant smuggling⁵.

In light of IOM support to the NCCPIM-TIP 6 on combating and preventing trafficking in persons and building capacities of relevant government officials and other target groups, as well as raising awareness on the risk and dangers of becoming victim to trafficking, synergies on relevant capacity building activities in this area will be sought .

EASO regional pilot project with priority countries: synergies to be identified with respect to topics and capacity building modalities.

1. Introduction

The present development engagement document details the objectives and management arrangements for the development cooperation concerning EASO (Q1 2021 – Q1 2023) [TBC] as agreed between the parties specified below. The development engagement document is annexed to the Bilateral Agreement with the Implementing Partner and constitutes an integrated part hereof together with the documentation specified below.

The present development engagement document is annexed to the *Agreement between the European Asylum Support Office and the Ministry of Foreign Affairs of Denmark on the modalities for the voluntary financial contribution to the Roadmap for Cooperation between EASO and EGYPT* (herein referred to as 'the Agreement') and constitutes an integrated part hereof together with the budget. The funds are part of Denmark's dedicated support for technical assistance and capacity building in the regions of origin and on the migratory routes.

2. Background

Following the Egypt-EU Migration Dialogue, which took place on 17 December 2017 in Cairo, the European Commission, taking stock of the interests expressed by the Egyptian authorities, proposed follow-up action points, including potential support by EASO in the areas of International protection and asylum and prevention of and fight against irregular migration, migrant smuggling and trafficking in human beings. This resulted in the first EASO-Egypt cooperation which was implemented in 2019-2020.

Based on several exchanges during the activities implemented in 2019-2020 and on ad-hoc consultations with Egyptian authorities, EASO and Egypt are to agree on a Roadmap (to be attached to the Agreement) which foresees two main areas of priorities:

- I. Supporting the establishment of asylum related legislation, institutions and systems in Egypt, and
- II. Supporting the establishment of effective protection-sensitive migration management strategies/procedures in Egypt.

Main outcomes and outputs are described in the tables below.

3. Development Engagement Objective

The main objective of the development cooperation among the parties is to contribute to the enhancement of the protection space for asylum seekers and refugees in Egypt in line with the CEAS and EU standards.

The MTF will base the actual support on progress attained in the implementation of the engagement as described in the documentation. Progress will be measured through EASO's monitoring framework as described in the Agreement to which this document is annexed.

For the Danish International Development Agency's (Danida) reporting purposes the following key outcome and output indicators have been selected to document progress:

The Contribution of DKK 2,100,000.00 (Two Million and One Hundred Thousand Danish Kroner) shall be paid in two instalments by the Danish Ministry of Foreign Affairs to EASO in DKK. The first instalment of DKK 1,400,000.00 (One Million Four Hundred Thousand Danish Kroner) will be paid following the entry into force of the Agreement and within 30 days from the receipt of the Debit note. The second and final disbursement of DKK 700,000.00 (Seven Hundred Thousand Danish Kroner) will be paid following the receiption of the Interim report and within 30 days from the receipt of the Debit note.

Any loss due to the variation of exchange rates between the grant in DKK and the currency used must be covered within the grant.

7.3 Accounting requirements

The accounting treatment of the Danish Contribution in the EASO Annual Accounts will be carried out in accordance with the accounting rules adopted by the European Commission's Accounting Officer which are based on the IPSAS (International Public Sector Accounting Standards). A reference to the outstanding balance of the Danish Contribution to EASO will be made in the disclosures of the annual accounts at the end of the year.

7.4 Financial reporting requirements

The financial report as per Article 6.2 of the Agreement to which this document is annexed, shall be drawn up to the same level of detail as is done in the budget (reflecting any agreed changes made). The report shall clearly state the disbursements made by the Danish Ministry of Foreign Affairs as well as consumption and outstanding balance at the time of reporting.

7.5 Unspent funds

Any unspent balance or any savings of project funds shall be returned to the Danish Ministry of Foreign Affairs (MFA) together with any interest accrued from deposit of Danish funds.

9. Anti-corruption clause

No offer, payment, consideration or benefit of any kind, which could be regarded as an illegal or corrupt practice, shall be made, promised, sought or accepted - neither directly nor indirectly - as an inducement or reward in relation to activities funded under this grant, incl. tendering, award, or execution of contracts. Any such practise will be grounds for the immediate cancellation of this grant and for such additional action, civil and/or criminal, as may be appropriate. At the discretion of the Danish MFA, a further consequence of any such practise can be the definite exclusion from any projects funded by the Danish MFA.

10. Child labour clause

The authority, organisation and/or consultant shall abide by the local laws and by applicable international instruments, including the UN Convention on the Rights of the Child and International Labour Organisation conventions.

11. Prevention of sexual exploitation, abuse and harassment

The Grantee agree to ensure that the engagement is implemented in an environment free from all forms of harassment, exploitation, abuse and harassment, sexual or otherwise, especially in case of vulnerable groups. Sexual abuse is defined as actual or threatened physical intrusion of a sexual nature, whether by force or under unequal or coercive conditions. Sexual exploitation is defined as any actual or attempted abuse of position of vulnerability, differential power or trust, for sexual purposes, including, but not limited to, profiting monetarily, socially or politically from the sexual exploitation of another. Sexual harassment is defined as any form of unwanted verbal, non-verbal or physical conduct of a sexual nature with the purpose or effect of violating the dignity of a person, in particular when creating an intimidating, hostile, degrading, humiliating or offensive environment.

The above definitions are referred to as Sexual Exploitation, Abuse and Harassment (SEAH).

EASO confirms:

- (1) that it has adequate policies/standards or frameworks in place to prevent SEAH³;
- (2) that all employees have been informed about these policies/standards/frameworks; and
- (3) that there are appropriate SEAH reporting procedures and complain mechanisms in the organisation including the protection of victims of SEAH and that prompt and adequate action is taken if SEAH is observed, reported or suspected.

In case the development engagement includes subgrantees, the grantee is responsible for ensuring the prevention of SEAH also at the level of subgrantee.

MFA has zero-tolerance towards SEAH and will consider non-adherence to point 1, 2 and 3 as grounds for immediate termination of grant.

12. Prerequisites

The Danish cooperation with the implementing partner will commence on the day of the signature and entry into force of the Agreement to which this document is annexed, by the duly authorized representatives of both Parties (as per Article 4 of the Agreement).
