STRATEGIC SECTOR COOPERATION PROMOTES DANISH SOLUTIONS **ABROAD**

"We need more Denmark in the world. Danish solutions on sustainable energy, energy-efficiency, environment and clean tech as well as food production is in high demand in many countries. Strategic Sector Cooperation aims at mobilizing the competencies of Danish public authorities directly in long-term strategic cooperation with counterpart authorities in developing and growth economies. Through this cooperation the Danish authorities promote Danish societal solutions that have been developed through partnerships between the public and private sector - for example know-how on green economy, urbanisation, agriculture and food as well as health.

The experiences and competencies of the Danish public sector institutions can provide useful inspiration for other countries in their efforts to improve framework conditions for sustainable development, green growth and social welfare. Strategic Sector Cooperation focuses on concrete development challenges and responds to current needs of the partner country.

By increasing the depth of the bilateral relations, the Strategic Sector Cooperation can also promote general bilateral dialogue and cooperation on broader political issues of joint interest. It also brings Danish experiences and state-of-the-art solutions to the table. These experiences can contribute to solving development challenges in partner countries while at the same time creating a platform for increased engagement of the Danish private sector in the partner countries.

THE STRATEGIC SECTOR COOPERATION HAS THREE **OBJECTIVES:**

- To contribute to inclusive, sustainable growth and development in partner countries by supporting conducive framework conditions for the fulfilment of the Sustainable Development Goals (SDGs).
- To strengthen and expand relations between Denmark and partner countries.
- To engage the Danish private sector in delivering solutions to the SDG challenges in partner countries. Private sector engagement is motivated through improved framework conditions, local network, knowledge and exposure to resource efficient, high-quality solutions.

Strategic Sector Cooperation operates within the framework of the Danish strategy for development aid and humanitarian assistance, "The World 2030", and within the Danish Government's new Strategy for Economic Diplomacy. In both strategies, Strategic Sector Cooperation is prioritized as an initiative that promotes sustainable growth and development by improving framework conditions in growth economies while simultaneously creating a platform for an increased commercial presence of Danish business.

A DANISH MODEL FOR DISTRICT HEATING AND CLEAN ENERGY IN TURKEY

Turkey imports the majority of the country's energy resources, which primarily consists of fossil fuels. The Turkish government is currently focused on strengthening the local and green energy production. One of the areas with the highest energy consumption is heating and cooling of buildings. The lack of a law regulating the heating sector or the market for heating is a challenge.

A Strategic Sector Cooperation (SSC) project between the Danish Energy Agency, the Turkish Ministry for Energy and the Danish Embassy in Ankara is focused on preparing a new piece of legislation on heating – if passed it would be the first legislation on heating in Turkey. The law focuses on energy efficiency and the promotion of district heating and district cooling. Technical experts from the Danish and Turkish public authorities are working closely and the private sector is involved as well. The law is expected to be finalized in the middle of 2018.

STRATEGIC SECTOR COOPERATION AND THE SUSTAINABLE DEVELOPMENT GOALS

Strategic Sector Cooperation operates within the framework of the SDGs and has direct as well as indirect effects on a number of the SDGs. Improving labour inspections and work environment helps increase the number of people with decent work and promotes economic growth while cooperating on food security and agricultural practices can help reduce hunger.

The SDGs' ambitious focus on global development and sustainable growth constitutes a window of opportunity to position Danish public and private solutions on for example clean energy, water efficiency and recycling. Through Strategic Sector Cooperation Denmark contributes to the implementation of the SDGs.

Strategic Sector Cooperation prioritises projects in growth economies. These countries play an increasingly larger role for global prosperity and progress towards the SDGs. However, sustainable solutions are needed to ensure long-term progress. Strategic Sector Cooperation embodies a Danish development approach with an enhanced focus on catalysing knowledge and solutions through partnerships.

SDG-OVERVIEW



Through SSC projects in Columbia, Mexico, Kenya, Vietnam and China, the Danish Ministry of Environment and Food cooperates with local authorities to improve food security and resilient agricultural practices.



Several SSC projects with the Danish Ministry of Health assist authorities in Mexico, Brazil, Vietnam and China in creating access to health-care services, to safe, effective and affordable medicine and vaccines for all.



A SSC project in Vietnam with the Danish Ministry for Education assists local authorities with improving the technical and vocational education and training in the country.



Several SSC projects have an indirect effect on gender equality, such as improving access to health-care for both men and women, education, health-care, access to medicine and individual growth.



Through SSC projects in South Afric a and India, the Danish Ministry of Environm ent and Food and the City of Aarhus are contributing to improve local water efficiency and reduce water wastage.



Several SSC projects with the Danish Ministry of Energy, Utiliti es and Climate in South Afri ca, Turkey, India and Indonesia cooperate with local authoriti es to ensure afford able, clean and modern energy.



SSC projects in Bangladesh and Myanmar assist local authorities in improving local labour inspections and thereby the work environment, particularly in the garment and textile sector.



Several SSC projects, e.g. on maritime affairs, digitalisation and energy contribute to building resilient infrastructure, promote technological development and innovation as well as enhance scientific research.



By securing e.g. health-care for all or individual economic growth for workers in the textile industry, some SSC projects also contributes to reduce inequalities in partner countries.



Three new SSC projects in South Africa, India and China focus on sustainable urban planning. The City of Aarhus and the City of Copenhagen are sharing their experience on sustainable cities with local authorities.



Through SSC projects in Kenya, Vietnam and Turkey, the Danish Ministry of Environment and Food is sharing Danish knowledge on circular economy, waste reduction and recycling.



Through a SSC project in China, the Danish Ministry of Environment and Food is working together with local authorities to conserve and ensure a sustainable use of freshwater ecosystems.



Through a SSC project in Brazil and a newly established project in Iran, the Danish Ministry of Industry, Business and Financial Affairs is helping to digitise the public sector and create more transparent institutions.



Strategic Sector Cooperation is facilitating partnerships between Danish public institutions and partner authorities but also laying the foundation for public-private partnerships in partner countries for the fulfilment of the SDGs.

ANIMAL WASTE TO VALUE

Chinese agriculture is booming with rapid modernisation. At the same time, challenges like food safety, exploitative methods of production, and polluted waterways are on the agenda of the Chinese consumers and authorities.

The Danish Veterinary and Food Administration, the Danish Environmental Protection Agency, SEGES and University of Aarhus are cooperating with the Chinese Academy of Agricultural Sciences in Beijing and Harbin Municipality on a SSC project on regulation of the use of animal manure as fertiliser on arable land. The project is introducing the Danish approach to regulation of animal husbandry from both an administrative and a technical point.

In the beginning of 2018, the Chinese State Council published new guidelines for regulating the agricultural sector. These guidelines follow the same ideas as the Danish regulation. This shift towards a Danish regulatory system is expected to increase Chinese interest in Danish agro-technology, farm systems and know-how.

Strategic Sector Cooperation creates opportunities for Danish companies. Whenever relevant, SSC projects are used as a platform for displaying Danish technical solutions and administrative and organisational models, and mobilizing additional Danish actors and resources, such as research institutions, investment funds and private companies.

Denmark has stationed 25 sector counsellors with sector expertise at Danish embassies. The sector counsellors play an important role to coordinate the projects and to facilitate a broader strategic sector dialogue.




Figure 1. The actors in Strategic Sector Cooperation

The sector counsellors work closely with the Danish Trade Council. Whilst the Trade Council offers assistance to specific companies, the sector counsellor works more broadly to address framework conditions. The Strategic Sector Cooperation modality supports sustainable and inclusive growth through partnerships with the public and private sector. Solutions to SDG challenges in partner countries can become business opportunities for Danish companies.

A DANISH FINGERPRINT ON MARITIME LEGISLATION IN GHANA

A maritime sector cooperation between Ghana and Denmark was signed in March 2017. It aims at improving maritime safety and the implementation of international maritime standards.

In autumn 2017, Ghana moved to propose new market restricting regulation in the maritime sector. Through Denmark's network and trusted relationships with maritime authorities, Denmark was able to facilitate a dialogue between the major international shipping nations, the shipping industry and Ghanaian regulators. The result was a revision removing the market restricting aspects in the regulation, which both the Government of Ghana and the industry favoured.

Executive Director Jacob K. Clasen, Danish Shipping, states: "In a recent situation where Danish ship-owners were faced with regulatory challenges and market restrictions in Ghana, Danish Shipping found the assistance of the maritime sector counsellor at the Danish Embassy in Accra extremely valuable. No doubt that the extended bilateral relations between Danish and Ghanaian authorities helped pave the way for an amicable solution to the challenges".

Partner countries have highlighted the great flexibility of the Strategic Sector Cooperation initiative. The Danish authorities' ability to draw on Danish experience relevant to a local challenges and their ability to understand barriers and challenges that affect development of for example regulative or policy issues in a sector is greatly appreciated amongst partner countries. Partners have expressed that this flexibility and attitude is unique and a key motivational factor for their willingness to engage, initiate, and invest their resources in SSC projects with Denmark.

The Danish knowledge and solutions gained through SSC projects are in high demand. When the Strategic Sector Cooperation was initiated in 2015, Denmark launched 20 projects in 12 countries. Only two years later, nine new projects were launched.

In China, the City of Beijing reached out to the Danish capital Copenhagen for a long-term collaboration to help tackle sustainability challenges. Due to Copenhagen's visionary and innovative city management – and close cooperation with innovative Danish companies – the city is leading in urban management of traffic congestion, air pollution, water scarcity, heavy rain and flooding, which are focus areas for Beijing and the Chinese government. A SSC project between the two cities was initiated in September 2017.

Since the Indian Government ratified the Paris Climate Agreement, India has sought cooperation with external partners to further its ambitions to move towards a higher share of renewable energy. This was expressed during a meeting between the Danish Minister for Energy, Utilities and Climate, Lars Christian Lilleholt, and the Indian Minister of Power, Coal, New and Renewable Energy, Piyush Goyal, in January 2017. Denmark's experience with renewable energy, energy efficiency and holistic energy planning was considered valuable for India's transition to renewable energy. Therefore, a SSC project between India and Denmark was initiated in November 2017.

COMPLEMENTARY TOOLS - SCHOLARSHIP PROGRAMME AND RESEARCH COOPERATION

In order to strengthen the value and depth of Strategic Sector Cooperation, a scholarship programme and research cooperation facility have been added as comple- mentary elements. These are managed by the Danida Fellowship Centre (DFC). The scholarship programme offers opportunities for continued education and learning in Denmark for partners. A window for research cooperation between Danish and local universities has been earmarked for the countries and sectors included in the Strategic Sector Cooperation.





