OVERVIEW

On 1 May 2026, EU's trade agreement with Mercosur (Argentina, Brazil, Paraguay and Uruguay) enters into force provisionally¹, easing EU companies' access to the four South American markets with a total of approx. 270 million inhabitants. Tariffs on hundreds of products will be entirely eliminated from day 1, and tariffs on other thousands of products will begin falling. Companies in the EU also gain easier access to public procurement markets in Mercosur and will benefit from other advantages that come with this historic agreement.

This report intends to give Danish exporters and importers a short overview of some of the immediate advantages of the trade agreement. The document includes a number of useful annexes, such as a list of the export goods which tariff zeroes from day 1. It is based on the research of the Danish missions in Brazil and public data available, and updates may be made. THINGS TO LOOK OUT FOR FROM DAY 1

367 products go to zero tariff immediately

On day 1, 367 product lines from the EU drop to 0% tariff in Mercosur. These cover live animals, fish, fruit, cereals, oil seeds, vegetable oils, and selected chemicals and textiles. The full list is in the attached Annex 3. Beyond these, another 708 tariff lines, which were already at 0%, are now locked in by the agreement, meaning they cannot be raised unilaterally in the future.

Tariff on more than 9,000 product lines starts falling

Tariffs on more than 9,000 product categories will start falling, depending on the category they fall into and the import tax of the product in question:

¹ Initially, the trade agreement enters into force provisionally, as it is subject to the approval of the European parliament.

The below table shows examples on how this will play out per year depending of the category and tariff rate that apply for the product in question.

- **Example:** Tariff on a product under category 4 (= 4 years to zero tariff) that before the agreement was 20%: the tariff will be reduced to 16% per 1st of May 2026 and by 4 percentage points each consecutive year, reaching 0% in 2030.

BEYOND TARIFFS

The benefits of the interim trade agreement go beyond tariffs reduction. Below some highlights:

- ✓ **More efficient customs and trade facilitation.** Ia., [Chapter 4](#) of the agreement requests the parties to simplify and review requirements and formalities wherever possible, with a view to the rapid release and clearance of goods. It also requests consultation with the other bloc before new rules are applied in the area.
- ✓ **Smoother certification process.** [Chapter 5](#) requests the two blocs to intensify their cooperation with a view to increasing mutual understanding of their respective systems and helping to eliminate or avoid the creation of technical trade barriers. Ia., for sectors listed in [Annex 5-A](#), Mercosur countries are requested to accept, as part of their conformity assessment, certificates and test reports from EU-based conformity assessment bodies accredited under ILAC/IAF or the IECEE CB Scheme (covering electrical/electrotechnical equipment). Over time, this may reduce duplicate testing and certification requirements.
- ✓ **Simpler food-safety procedures.** [Chapter 6](#) introduces possible pest-free area recognition and equivalence of sanitary measures.
- ✓ **Trade in Services and Establishment.** [Chapter 10](#) requests national treatment in certain sectors for EU firms setting up in Mercosur. Investment protection (ISDS) is not included — it awaits the broader partnership agreement ratification.

Improved public procurement access

Until now, EU suppliers had no international treaty guaranteeing non-discriminatory access to public tenders in the Mercosur-bloc. The agreement changes this, as it gives national treatment to EU suppliers in a wide range of sectors ([Chapter 12](#) + annexes). The thresholds are defined in approximately EUR 265,000 for goods and services, down to EUR 160,000 after 7 years. For construction the threshold is EUR 10 million, down to 6 million after 7 years. The access includes all four countries, with a phased opening at sub-federal/local levels.

ANNEX 1: OVERVIEW OF TARIFF TREATMENT IN SELECTED DANISH STRONGHOLD SECTORS

ANNEX 2: IMPORTING FROM MERCOSUR

Tariff Reductions on Mercosur Goods Entering the EU

The agreement also reduces EU tariffs on imports from Mercosur. The EU will eliminate tariffs on approximately 92% of Mercosur exports to the European market. For Danish supermarkets, food importers, and trading companies, this creates lower procurement costs and new sourcing options. Below examples of immediate changes (1 May 2026):

- ✓ Green (raw) coffee: Tariff and quota free from Day 1.
- ✓ Vegetable oils (including soybean oil): Immediate tariff elimination.
- ✓ Fresh and frozen fish (~80% of categories): Tariff-free on implementation, including shrimp and lobster.
- ✓ Industrial ethanol: 450,000-tonne tariff-free quota for chemical industry use.
- ✓ Hilton Quota beef (10,000 tonnes): Existing 20% tariff drops to 0% immediately.

On quota competition

All quotas listed above are EU-wide. The 99,000 tonnes of beef or 1,000,000 tonnes of corn are shared among all 27 EU member states. Danish importers will compete for quota access with counterparts across the entire European market, including major buyers in Germany, the Netherlands, Italy, Spain, and France.

The method of allocation varies by product. EU agricultural TRQs are managed either through import licences (allocated proportionally to quantities applied for by EU importers) or on a first-come, first-served basis (where the quota fills in order of customs declarations until exhausted). For beef and poultry specifically, the agreement allows Mercosur countries to manage quota allocation on the export side, meaning that Mercosur exporters, not EU importers, receive quota entitlements. In practice, this favours large, established export groups with the logistical and financial capacity to secure allocations.

Phased tariff elimination on key retail products

- ✓ Orange juice: reduced to 0% over 7-10 years, with a 50% preference margin from Day 1.
- ✓ Roasted and soluble coffee: 4% tariff eliminated over 4 years.
- ✓ Avocados: 4% tariff eliminated over 4 years.
- ✓ Lemons and limes: up to 14% tariff eliminated over 7 years.
- ✓ Melons and watermelons: up to 9% tariff eliminated over 7 years.

Example of partial reductions: butter (30% reduction), bananas (fixed duty of €75/t). Excluded products: lamb, milk/cream/whey, wheat.

Safeguard mechanism: under Chapter 9, bilateral safeguard measures may be applied if preferential imports increase in such quantities as to cause or threaten serious injury to a domestic industry. An investigation based on at least 36 months of data is required before measures can be imposed.

The following products drop to 0% tariff on Day 1. The rate columns show the current MFN tariff for each Mercosur country that will be eliminated on 1 May 2026. Most rates are identical across all four countries (Mercosur Common External Tariff). Where rates differ, this reflects national exceptions. Products already at 0% base rate (708 additional lines) are not listed.
