Printed and signed ApplyVisa cover letter. Signature must match passport.		
Signed passport. Must be issued within the last 10 years, have two blank pages and be valid for at least 3 months beyond your intended stay in the Schengen area.		
If available, previous passport. All previous Schengen visas and stamps must be provided.		
Proof of UK residency (via immigration Share Code: gov.uk/evisa/view-evisa-get-share-code-prove-immigration-status). Residency must be valid 1 month beyond your planned trip to the Schengen area.		
Proof of UK arrival (date when you came to live in the UK; e.g., UK D-sticker; arrival stamp or letter from Home Office).		
Valid travel and medical insurance. Must cover the requested travel dates and be valid for the entire Schengen area.		
Proof of sufficient funds for the stay Original UK bank statements showing the balance and your name, covering the last 3 calendar months (approx. £40 per day). - If sponsored by spouse: marriage certificate + sponsorship letter + spouse's bank statements.		
Invitation from host in Denmark – online invitation (VU2) ID number or signed and dated invitation incl. relationship with applicant and dates of visit. Host must provide a copy of data page in passport and if applicable, proof of Danish residency. <i>Family relationship must be documented.</i>		
Proof of travel plan – e.g. reserved return ticket or sufficient means to cover such costs. If not staying with host, also include reserved accommodation or sufficient means to cover such costs.		
Evidence of occupation – on letterhead, signed, and less than 1 month old. - Employment: Letter from employer incl. salary and position of applicant <u>AND</u> 3 months' payslips - Self-employed: Accountant letter incl. annual salary drawn and self-assessment form edited by revenue and customs authorities - Student: Letter of enrolment/confirmation of student status.
