- I understand that **the Embassy recommends not buying any tickets before I know if my visa has been approved.**
- Applications **received by the Embassy less than fifteen (15) calendar days** before the intended travel date **may be deemed inadmissible** and returned without processing.
- **I am aware of the Embassy's current processing times** and understand that during extended processing times my travel plans may be affected if they fall within this extended processing period.
- **Misuse of a Danish Schengen visa**, including travelling to another Schengen country on a single-entry visa or travelling to another Schengen country before Denmark on a multiple-entry visa, **may result in denied entry, visa revocation, and negative consequences for future visa applications.**
- **I am solely responsible for ensuring that all documents and information submitted are genuine, authentic, and accurate**, regardless of whether they were obtained or submitted through a third party.

(Signed) current passport. Must be issued within the last 10 years, have two blank pages and be valid for at least 3 months beyond your intended stay in the Schengen area.		
If available, previous passport. All previous Schengen visas and stamps must be provided.		
Original birth certificate with both parents' names (+ copy to be stamped with original seen at VFS) - If one parent has sole custody or guardianship of the minor: Birth certificate mentioning one parent OR Death certificate of absent parent OR Court ruling must be provided.		
Proof of UK residency (via immigration Share Code: gov.uk/evisa/view-evisa-get-share-code-prove-immigration-status). Residency must be valid 1 month beyond your planned trip to the Schengen area.		
Proof of UK arrival (date when you came to live in the UK; e.g., UK D-sticker; arrival stamp or letter from Home Office).		
Valid travel and medical insurance. Must cover the requested travel dates and be valid for the entire Schengen area.		
Proof of sufficient funds for the stay Original UK bank statements showing the balance and your name, covering the last 3 calendar months (approx. £40-60 per day). - When sponsored by a parent: Sponsorship letter + parent's bank statements as per above.

Original passport of both parents (+ copy of bio-page to be stamped with original seen at VFS) - If applicable, parents' residence permit/share code for proving UK immigration status
