I acknowledge that:

- **This checklist applies when I lodge an application under the EU-rules**, namely, Directive 2004/38/EC of 29 April 2004 on the right of citizens of the Union and their family members to move and reside freely within the territory of the Member States.
- **EU law no longer applies in the UK or to British citizens.** Therefore, family members of British citizens are no longer eligible to apply for a visa under the EU-rules on free movement.
- If I submit an application under the EU regulation, but is **not eligible for it**, I will be contacted by the Embassy. Depending on the circumstances, I will either be given the **opportunity to withdraw the application** and can apply again under the normal rules **or my application will be submitted to the Danish Immigration Service (DIS)** for their decision. If the Danish Immigration Service then assesses that I am not eligible to apply under the EU regulation, my application will be refused based on the failure to demonstrate that I am covered by the Directive 2004/38/EC.
- **I can check newtodenmark.dk for guidance** on the EU-rules and which family members are covered.
- If any documents are marked with NO below, my application may be considered incomplete, and **I must submit the missing documents through VFS within five (5) calendar days.**
- I understand that **the Embassy recommends not buying any tickets before I know if my visa has been approved.**
- **I am solely responsible for ensuring that all documents and information submitted are genuine, authentic, and accurate**, regardless of whether they were obtained or submitted through a third party.

Signed passport. Must be issued within the last 10 years and have two blank pages. - If available, previous passport – all previous Schengen visas and stamps must be provided.		
Proof of UK residency (e.g., Immigration Share Code).		
Proof of EU/EEA/Swiss nationality – Original EU, EEA or Swiss passport of family member must be provided + copy to be stamped with original seen at VFS		
Proof of family relationship with EU/EEA/Swiss family member – Original marriage certificate, birth certificate or other reliable proof of family relationship must be provided + copy to be stamped with original seen at VFS		
Proof of travelling together with or joining the EU/EEA/Swiss family member - Choice of any proof e.g. flight/hotel reservation, invitation, letter from family member etc.		
Minors (under 18 years) – the following documents must also be provided:		
Original birth certificate for the minor with both parents' names (+ copy stamped at VFS) - If one parent has sole custody or guardianship of the minor: Birth certificate mentioning one parent OR Death certificate of absent parent OR Court ruling		
Original passport of both parents (+ copy of bio-page to be stamped with original seen at VFS) - If applicable, parents' residence permit/share code for proving UK immigration status		
Written consent for issuance of visa from both parents/guardian(s): Please be aware of the following rules in the UK: Get permission to take a child abroad - GOV.UK
