- I understand that the Embassy recommends not buying any tickets before I know if my visa has been approved.
- Applications **received by the Embassy less than fifteen (15) calendar days** before the intended travel date may be deemed inadmissible and returned without processing.
- I am aware of the Embassy's current processing times and understand that during extended processing times my travel plans may be affected if they fall within this extended processing period.
- I am solely responsible for ensuring that all documents and information submitted are genuine, authentic, and accurate, regardless of whether they were obtained or submitted through a third party.

Printed and signed ApplyVisa cover letter. Signature must match passport.		
Signed passport. Must be issued within the last 10 years, have two blank pages and be valid for at least 3 months beyond your intended stay in the Schengen area.		
Proof of UK residency (via immigration Share Code: gov.uk/evisa/view-evisa-get-share-code-prove-immigration-status). Residency must be valid 1 month beyond your planned trip to the Schengen area.		
Proof of UK arrival (date when you came to live in the UK; e.g., UK D-sticker; arrival stamp or letter from Home Office).		
Proof of sufficient funds for the stay – original bank statements showing the balance and your full name and address, covering the last 3 calendar months – approx. DKK 350-500 per day - If sponsored by spouse: Marriage certificate + sponsor letter + spouse's bank statements - Minors sponsored by a parent: Birth certificate + sponsor letter + parent's bank statements		
Proof of purpose of stay (+ dates of intended stay) – e.g. flight/ferry/hotel/cruise reservations, itinerary or invitation from host in Greenland/Faroe Islands. Invitations must be dated, signed, explain the purpose of stay and contain the host's contact details - If your flight/ferry/cruise reservations show transit in the Schengen area, you must also provide copy of your valid Schengen visa (alternatively, provide explanation on how you will obtain a Schengen visa valid for the given period)		
Minors (under 18 years) – the following documents must also be provided:		
Original birth certificate for the minor with both parents' names (+ copy stamped at VFS) - If one parent has sole custody or guardianship of the minor: Birth certificate mentioning one parent OR Death certificate of absent parent OR Court ruling		
Original passport of both parents (+ copy of bio-page to be stamped with original seen at VFS) - If applicable, parents' residence permit/share code for proving UK immigration status		
Written consent for issuance of visa from both parents/guardian(s): Please be aware of the following rules in the UK: Get permission to take a child abroad - GOV.UK
