³⁾ NB: A fee of EUR 35 (DKK 260 / MYR 161) shall be charged for countries with which the European Commission has concluded or is negotiating a visa facilitation agreement.

⁴⁾ Where several documents are issued together to the citizen, a total fee of DKK 285 (MYR 177) shall be charged.

⁵⁾ Provided the request for VAT refund comprises several separate purchases, a fee of DKK 230 (MYR 142) shall be charged per statement.

⁶⁾ Where several provisional passports or extensions of passports are issued at the same time, a fee of DKK 2,675 (MYR 1658) shall be charged for the first passport and DKK 1,145 (MYR 710) or DKK 1,786 (MYR 1107) for subsequent passports.

⁷⁾ Where several provisional passports or extensions of passports are issued at the same time, a fee of DKK 3,820 (MYR 2367) shall be charged for the first passport and DKK 1,145 (MYR 710) or DKK 1,786 (MYR 1107) for subsequent passports.

⁸⁾ The fee may increase to 135 or 180 if an implementation decision has been adopted in the EU in accordance with the Visa Code Article 25a. Does not apply to children up to and including eleven years of age.
